## 2021 Finance & Giving

*This leaflet is intended for people who come to St Lawrence regularly. If you're a guest you're welcome to read it, but we're not asking you for money!*

### Your Giving

When we talk about "Church Finance" we mean "what we do with the money you give". We don't get Government support, or money from some central CofE fund, it's all from giving, and all supports our work of mission in the name of Jesus Christ - so thank you!

*"Each of you should give what you have decided in your heart to give, not reluctantly or under compulsion, for God loves a cheerful giver." (2 Corinthians 9:7)*

### Budget

Your Church Council (the 'District Church Council', or DCC) has again this year put together a budget to help us manage our finance with care. For 2021, we've set a **target** for our giving, which includes giving specific amounts to our **Mission Partners**.

*"Bring the whole tithe into the storehouse, that there may be food in my house. Test me in this,' says the LORD Almighty, 'and see if I will not throw open the floodgates of heaven and pour out so much blessing ...'" (Malachi 3:10)*

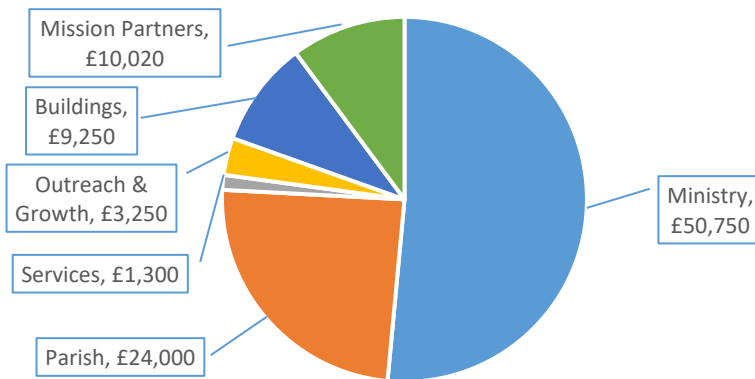
### Target

We think that we need around £98,700 for this year. Over the page there's a diagram of how we get that figure...

*"Ministry" goes towards the cost of supporting Clergy. The Rector's stipend is £27,342 but there are many other costs (buildings, training, Diocesan staff etc).*

*"Buildings" includes energy costs, and some maintenance*

*"Outreach and Growth" is a remarkably low amount but covers the important costs of doing these vital parts of our mission.*



## Mission Partner Support

By giving to support our Mission Partners, we join with them in their Gospel work, to the glory of our Lord Jesus Christ.

*“Even when I was in Thessalonica, you sent me aid more than once when I was in need.” (Philippians 4:16)*

For 2021 about 10% of our budget will be sent to Mission Partners. This means that everyone who gives will be contributing towards this.

In 2020 we completed a major project to repair the historic large stained-glass window and stone surround at the East end of the building. The cost of around £160,000 was fully covered by a grant from the Suez Community Fund and the Ivy Morris Fund (from a legacy). Please consider including St Lawrence Church in your will.
